HISTORICAL NOTE

Coleridge is a farming community located in the south-central part of Cedar County, Nebraska, in precinct #16. The village was located by the railroad in 1883 and the first town lots were sold in August of that year. The village was incorporated June 6, 1885, and the first meeting of the town board was held on June 16. The first village election was held in April of 1886.

Coleridge had the first railroad depot in the area erected in 1883. The Chicago and Northwestern railroad serviced the town. This road abandoned its lines in Coleridge in 1972.

School in the area was taught as early as 1875. Coleridge began its own school in 1884 and the first school building was erected the next year.

The town was named by a railroad for a distinguished visitor to the United States from England, Lord John Coleridge.
