HISTORICAL NOTE

Clarence A. Davis was born in Beaver City, Nebraska, in 1894. He graduated from Nebraska Wesleyan University in 1913 and received his bachelor of laws degree from Harvard University three years later. Following two years of general practice, he was elected as Nebraska Attorney General, serving from 1918 to 1923. He then returned to general practice in Holdrege from 1923 to 1936 and in Lincoln from 1936 to 1953.

Mr. Davis was known for his promotion of the generation and distribution of electric power at the national, state, and municipal levels. He was counsel first to private power companies and then to the public power districts which were established in the 1930's. He was also involved in interstate water litigation, serving frequently as counsel to the state of Nebraska in that area and in preparation of the Nebraska-Colorado interstate compact regarding the South Platte River.

He was appointed Solicitor of the United States Department of the Interior in 1953 and Undersecretary in 1954. He resigned from that post in January 1957 and again resumed private practice in Nebraska and in Washington, DC.

He was a member of the Lincoln, Nebraska State and American Bar Associations. He served as president of the Nebraska State Bar Association and the Federal Bar Association and was a member of the board of governors of the American Bar Association. He was director of the American Judicature Society and a member of the Institute of Judicial Administrators and the American Law Institute.

Mr. Davis died in May 1974.

SCOPE AND CONTENT NOTE

The collection of the papers of Clarence A. Davis consists of 83 boxes and 11 volumes arranged in five series: (1) Records of the U.S. Department of the Interior, 1954-1957; (2) Subject Files; (3) Correspondence, 1918-1974; (4) Publications; (5) Scrapbooks, 1910-1971.

The bulk of this collection relates to the period following 1957 after Davis had left the Department of the Interior. The most voluminous of these records is Series Two, his subject file. These papers include correspondence, speeches, clippings, reports, and a variety of pamphlets, brochures, bulletins, advertisements and other printed matter. This material was taken directly from Mr. Davis's filing cabinets after his death. Several attempts have been made to discern an

order. Parts of it appear to be in alphabetical order, but others do not and there is no consistency in the phrases used on folder labels to describe the same subject or organization. Consequently, Davis's filing order as well as his folder titles have been retained.

In addition to files relating to water and power, there are many on outdoor advertising which increasingly occupied Davis's professional life in his later years.

Series One consists of a few records from his tenure with the Department of the Interior. Most of this material relates to what is known as the Al Sarena Mines case, a long-standing dispute over claims to mineral rights on public lands in southern Oregon. Also in this series are two notebooks of information compiled on the constitutional and legal position of the federal government regarding water and power since the early 19th century.

The correspondence begins in 1918 but contains relatively little material before the late 1950's. Beginning in 1961 the volume of letters increases and the file appears to be complete, containing both business and personal correspondence.

The publications consist of briefs of cases in which Davis was involved as well as journals of law associations during his service as officer. The scrapbooks contain mostly clippings but also other memorabilia from all phases of his life and work beginning in 1910.

This collection was received in July 1974 from Thomas M. Davis II of Falls Church, Virginia, courtesy of George H. Turner of Lincoln and Wilber S. Aten of Holdrege, executors of the estate of Clarence A. Davis.
