### SCOPE AND CONTENT NOTE

This collection consists of thirty-six volumes of financial ledgers arranged in fourteen series: (1) Journals, 1879-1889; (2) Ledgers, 1879-1888; (3) Discount Registers, 1879-1919; (4) Remittance Registers, 1907-1914; (5) Draft Registers, 1905-1914; (6) Collection Registers, 1879-1889; (7) General Balance Ledger, 1879-1886; (8) Certificate of Deposit Ledgers, 1905-1914; (9) Teller's Counter Cash Ledgers, 1905-1915; (10) Day Books, Verdon State Bank, 1909-1918; (11) Journals, Verdon State Bank, 1905-1916; (12) Cash Books, 1905-1920; (13) Sight Draft Record, 1915; and (14) Miscellaneous Ledgers, 1873-1888.

The collection relates to the financial affairs and activities of the Farmer's and Merchant's Bank of Humboldt, Nebraska, 1879-1919, and also includes several journals of the Verdon State Bank, which may have had some association with the Farmer's and Merchant's Bank. Also contained within the collection are several miscellaneous records relating to various businesses in Falls City, Nebraska. The origin and relationship of these materials was not determined at the time they were discovered in the vaults of the Richardson County Courthouse, Falls City, Nebraska, June 1973.
