BIOGRAPHICAL NOTE

Born in Auburn, Nebraska on September 29, 1972, Tony Fulton graduated from Auburn Senior High School in 1990. He attended the University of Nebraska Lincoln, graduating in 1997 with a bachelor's degree in mechanical engineering. He also studied philosophy at Kansas Newman University and received a Master of Divinity degree in Theology from Franciscan University of Steubenville in Ohio. Fulton was appointed to the Nebraska State Legislature in 2007 to replace Mike Foley, who was elected as Nebraska's Auditor General. He won re-election for District 29 in 2008. Due to term limits, Fulton could not run for re-election in 2012. Sen. Kate Bolz filled the District 29 seat in January of 2013.

SCOPE AND CONTENT NOTE

The collection consists of four boxes of legislative files including legislative bill files, briefing materials, subject files, etc. Arrangement of the files was left as originally received from Sen. Fulton's office.
