Lt. Gov. Roland A. Luedtke (1979-1983)

History:

Roland A. Luedtke was born on January 4, 1924, in Lincoln, Nebraska. He attended Lincoln Public Schools and graduated from Lincoln High School in 1942. After serving in World War II (ETO Combat and Infantry), Luedtke earned his B.S. degree from UNL in 1949 and received his law degree three years later. He married Helen D. Snyder on Dec. 1, 1951, and they eventually had two sons. Luedtke became a practicing attorney and partner in the law firm of Kier, Cobb, Leudtke, Swartz, & Wieland. His political career began when he became the Deputy Secretary of State from 1953-1959. Luedtke was also Lancaster County Republican Chairman from 1962-1964 and was elected in November 1966 to the legislature for a four-year term. He served as Lieutenant Governor from 1979-1983 and was a Senator representing the 28th District . Luedtke continued in public service as the mayor for the city of Lincoln from 1983-1987, and he died on July 22, 2005.
