SCOPE AND CONTENT NOTE

Collection consists of the records of Howard County, Nebraska, on microfilm arranged into ten subgroups: 1) Assessor; 2) Treasurer, 1871-1969; 3) County Board of Commissioners, 1871-1978; 4) County Clerk; 5) Register of Deeds, 1872-1921; 6) County Court, 1872-1926; 7) District Court, 1872-1978; 8) Superintendent of Schools, 1874-1971; 9) School District Records; and 10) County Surveyor, 1867-1978.

There are currently no records in storage for Subgroup One, County Assessor.

Subgroup Two, County Treasurer (in process), consists of twenty-six reels of microfilm for the Tax Lists, Real Estate and Personal, of Howard County, 1871-1969.

Subgroup Three, County Board of Commissioners, (in process) includes six reels of microfilm copied from security film containing the minutes of the County Board of Commissioners.

Subgroup Four, County Clerk, consists of the marriage records of Howard County, 1872-1954, on microfilm produced by the Genealogical Society of Utah in cooperation with the Historical Society in August of 1997.

Subgroup Five, Register of Deeds, contains deed registers for Howard County, 1872-1921, (in process) on 13 reels of microfilm copied from security microfilm of Howard County stored at the Nebraska State Historical Society. Some miscellaneous records from the Register of Deeds office appear on microfilm for other subgroups and series.

Subgroup Six, County Court, is the only subgroup which was microfilmed by the Historical Society. This subgroup consists of Justice of the Peace Dockets, 1877-1899, and civil dockets, 1872-

1911. These records were transferred to the State Archives in February of 1979.

Subgroup Seven, District Court, consists of five reels of microfilm produced by the county and copied by the Historical Society for its reference patrons. This subgroup is divided into two series: 1) Naturalizations, 1872-1929; and 2) General Index to the District Court, 1875-1978. The original volumes of Naturalization Records and additional such records, including the card index, remain at the Howard County District Court.

Subgroup Eight, Superintendent of Schools, contains six reels of 35mm microfilm produced by the county in 1978 of the School Census for Howard County, 1874-1971. The early year census records have little organization on microfilm and not all years are divided by targets.

There are currently no records in storage for Subgroup Nine concerning Howard County School District records.

Subgroup Ten includes two reels of microfilm containing the Survey Record Books for Howard County, 1867-1978.
