HISTORICAL NOTE

Saline County, located in the southeastern part of Nebraska is bounded on the north by Seward County, Lancaster and Gage counties on the east, Jefferson County on the south and Fillmore County on the west.

Due to the fact that the Big Blue River and its tributaries cross through the county, it is well suited to agriculture and stock raising.

Victor Vifquain, a medal of honor winner, distinguished general of the civil war, U. S. Consul, and later Adjutant General of Nebraska, was one of the first settlers in Saline County on the West Blue River. Saline County had a population of nearly 15,000 in 1880. Currently the county population is 12,715 (1990). The county had its peak population in 1890 at 20,097.

The county was surveyed and set apart in 1855 but was not officially organized until February 18, 1867. Swan City was first selected as the county seat. At an election to locate the county seat in 1871, Pleasant Hill gained the honor and held it until 1877 when the present county seat of Wilber was selected. It was at this time that the first courthouse was erected in 1868.

The first school was located six miles northwest of Crete. By 1880 there were 106 school districts. These have been reduced to 12 districted in 1990.

Crete, a major town in the county was layed out in 1870 and incorporated in 1872. Today Crete is a second class city with a population of 4,841. Doane College had its beginning in Crete in 1872. Crete Mills was the first business to open in the town in 1870.

Wilber, the county seat, was laid out in 1872 by C. D. Wilber. Today it has a population well under that of Crete at 1,527.

SCOPE AND CONTENT NOTE

This collection consists of the official records of Saline County arranged into nine subgroups: 1) Assessor, 1878-1937; 2) Treasurer, 1868-1976; 3) County Board of Commissioners, 1867-1968; 4) County Clerk, 1868-1991; 5) Register of Deeds (no records); 6) County Court, 1866-1897; 7) District Court, 1912-1972; 8) Superintendent of Schools (no records); and 9) School Districts, 1873-1922.

Subgroup One, Assessor, was recently accessioned and has not yet undergone a volume by volume inventory. Patrons please provide date of assessment required, name of subject, and township or precinct to access these volumes. In the case of real estate assessments, please provide legal description, township or precinct and city or town of property location.

Subgroup Two, Treasurer, Series One, was also recently acquired and has not as yet been inventoried. This subgroup is arranged into six series: 1) Tax Lists, 1868-1967; 2) Delinquent Tax Lists, 1868-1967; 3) Tax Sale & Redemption Records, 1869-1954; 4) Motor Vehicle Tax Lists, 1935-1947; 5) School Land Records, 1870-1967; and 6) Miscellaneous Volumes, 1872-1959. Miscellaneous includes two Motor Vehicle Registers, 1911-1921.

The bulk of Subgroup Three, County Board of Commissioners, contains the minutes of the Board on microfilm, 1868-1968.

Subgroup Four, County Clerk, is arranged into four series: 1) Marriage Records, 1868-1991; 2) Election Records, 1871-1976; 3) Bounty and Estray Records, 1872-1933; and Miscellaneous, 1874-1935.

Series One, Marriages, was microfilmed by the Genealogical Society of Utah at the county courthouse in cooperation with the Nebraska State Historical Society, 1994-1995. Some records of this series may be restricted from public use due to the presence of confidential records defined in section 71-612 of the Revised Statutes of Nebraska. All sensitive material has been spliced from the reference reels. For copies of documents which have been removed, patrons are advised to contact the county clerk or the Nebraska Bureau of Vital Statistics.

Series Two, Election Records, is divided into three subseries: 1) Election Abstracts, 1878-1976; 2) Voter Registrations, 1922-1976; and 3) Election Board Records, 1952-1968. This series was previously microfilmed as series two through four on the old inventory. Patrons are requested to ignore series numbers on microfilm. Cross-references have been made on reinventory to the corresponding numbers on microfilm.

Series Three, Voter Registrations, includes two volumes of registers for Absent and Disabled Voters, 1922-1926 (not microfilmed) and 1930-1976 on reel #9.

Series Four includes an Election Board Record, 1952-1968, microfilmed as series four, Vol. #2 on reel #9.

There are no records in storage for Subgroup Five, Register of Deeds.

Subgroup Six, County Court, contains only fragment entries from Justice Dockets of the County Court, 1866-1897, located in Series One.

Subgroup Seven. There is one box of misc. Bills of Exception (BOE) and one box of bar appearance docket books/court calendars in storage for Subgroup Seven, District Court

The same applies to Subgroup Eight, Superintendent of Schools, including the School Census for the county, except for School Dist. #91 below.

Subgroup Nine contains the records of School District #91, 1873-1922, including minutes, 1873-1876; Boundary Records, 1876-1899 and 1922; a school census, 1868-1872; and register of Tax Levies, 1870-1879.

The County Commissioners proceedings and Election Records were loaned to the Historical Society for microfilming by the County Clerk in 1976. The marriage records were microfilmed by the Genealogical Society of Utah in 1994-1995, and the remainder of the collection was accessioned by the Archives in 1989.
