BACKGROUND NOTE

In September, 1971, Dwight and Janelle Hoxie, and M. Marshall Dixon took steps to contact Sierra Club members in the Lincoln, Nebraska area. In the same month, an organization meeting was held to begin the group and to select organizational leaders. The Bluestem Chapter was first part of the Rocky Mountain regional Sierra Club group, but in 1974 the Nebraska chapter was formed out of the Rocky Mountain group. The Bluestem group was one of five smaller local chapters in Nebraska.

SCOPE AND CONTENT NOTE

The collection contains records of the Bluestem group from its creation in 1971 to 2002. The collection includes the bylaws and constitution of the group, job descriptions of the group, minutes, financial records and newsletters. The collection also includes the subject files of the major issues that the group faced.
