## HISTORICAL NOTE

The Territorial legislature of 1856 created the boundaries of present Thayer County, originally known as Jefferson County. Jones County was also created which corresponded with the boundaries of present-day Thayer County. These were combined in 1867 and the name Jefferson County was retained. The county was divided in 1870-1871 and the present Thayer County was created. It was named in honor of General John M. Thayer, Nebraska Civil War General. The records of Thayer county began with the first minutes of the Board of Commissioners in 1871.

## SCOPE AND CONTENT NOTE

The records of Thayer County are arranged into Ten Subgroups: 1) County Assessor (no records); 2) County Treasurer (no records); 3) County Board of Commissioners, 1871-1974; 4) County Clerk, 1870-1994; 5) Register of Deeds, 1863-1972; 6) County Court, 1871-1921; 7) District Court (no records); 8) Superintendent of Schools (no records); 9) School District Records, 1902-1967; and 10) Thayer County Memorial Hospital, 1968-1982.

The Archives has not accessioned any assessment or tax records from the county.

Subgroup Three, County Board, consists of minutes of meetings and resolutions, 1871-1974. This microfilm was copied from security microfilm held for the county. The volumes are not in strict order on the microfilm.

Subgroup Four consists of the Marriage records of the county, 1870-1994. These records were microfilmed by the Genealogical Society of Utah in 1995. Some of the images may be difficult or impossible to copy. Patrons need to contact the county clerk for copies from the original record if this occurs. Also included are miscellaneous records which appear on security film copied for other subgroups. It is identified in this record in case it may be useful to patrons.

Subgroup Five consists of miscellaneous records as above. They appear on the reels but are not a complete run of a series. Of particular are the fourteen volumes of original patent entries which give date of purchase, part of section, name of purchaser and date. They are arranged by section, township, and range on the film.

Subgroup Six contains two Justice Dockets of Series Two. There are not probate records at the archives. Patrons must contact the county court for probate.

Records in storage of Subgroup Seven, District Court, consist of Bar Appearance Docket Books/Court Calendars from 1917-1924. The State Archives does not hold and naturalization records from the county. Contact the District Court for case files, journals, complete records, appearance dockets, general indexes, and naturalization records.

There are no records for the Superintendent of Schools in the Archives for Thayer County. This includes the county school census. Contact the County Clerk for access to this record.

Subgroup Nine is divided into Three Series: 1) School Dist #4, 1935-1963; 2) School dist. #24, 1907-1967; and 3) School Dist. #36, 1912-1963. These records are on two reels of microfilm and are not readily accessible in the reference room. They may contain confidential records per schedule #10 and can only be referenced by the staff of the Historical Society. This refers to attendance records, health records, and grade reports.
