### HISTORICAL NOTE

The first settlers at the site of Ashland, Nebraska Territory, came in 1856. By 1858, Ashland was known as a depot of supplies for freighters and emigrants. The town began to develop in 1863 with the construction of a general store and a year later a mill. Ashland became the first county seat of Saunders County and held that position until 1873 when the position went to Wahoo, Nebraska. A court house was built at Ashland in 1870 but the property was sold in 1878.

Ashland was named when the Legislature changed the names of Saline Ford and Flora City to Ashland in 1866. The town was formally organized February 2, 1870. In 1868 there was a population of approximately 150 people. It became a second class city with a population of over 1500 in 1886. The population in 1990 was 2,274.

The Burlington and Missouri River Railroad built to Ashland in May of 1870 and its successor the Burlington Northern is the only road servicing the community.
