Introduction:

The Nebraska Commission on the Status of Women (NCSW)was an agency of the State of Nebraska. NCSW was governed by a Commission of 30 persons from across Nebraska, and the Commission maintained an office and staff in the State Office Building in Lincoln.

The NCSW was dedicated to women having the opportunity and freedom to fulfill the role(s) they choose to pursue in today's society. The Commission served women directly, sought to increase awareness and understanding within business, industry, government and the public concerning the issues confronting women in education, in the workplace and in the general society. The Commission achieved these ends through research, legislation, information and referral, publications, training and technical assistance, outreach services and networking.

The commission was committed to the principle that women should have the opportunity and freedom to fulfill the roles they choose to pursue without discriminatory barriers. The Commission was especially concerned about improving women's wages and raising women's standard of living. In addition, the NCSW sought to increase public awareness and understanding of societal issues affecting all facets of women's lives-within the family, workplace, educational settings and other private and public institutions.

Following the creation of President Kennedy 's Commission of the Status of Women in 1961, individual states were encouraged to organize Commissions to meet their specific needs in addressing the complexity of problems and issues faced by women. Governor Frank B. Morrison established such a commission in 1964 naming it the Nebraska Governor's Commission on the Status of Women. Thirty-nine members were originally appointed to study, report, and offer recommendations on improving the status of women.

The Commission became a statutory state agency in 1971 with the first staff hired and doors opened to the public in 1974. In 1975, the Commission's name was changed to the Nebraska Commission on the Status of Women and membership set at 30. An equitable political and geographical balance was achieved through gubernatorial appointment of five members from each of the six Supreme Court Districts and not more than one-half of the members serving from one political party.

Commissioners served for three-year appointments with ten members retiring each July. The five working Committees which carry out the NCSW goals are Home, Community, and Personal Crisis; Women under the Law; Talent File; Education and Employment and Public Relations.

Purpose of NCSW:

The NCSW studied the changing and developing roles of women in the American Society by:

- Identifying and setting priorities on the establishment of programs to address women's concerns
- Informing leaders in the private and public sectors about the nature, scope, and elimination of sex discrimination and stereotyping
- Coordinating and working with various women's organizations
- Acting as an information and referral service for anyone seeking help for personal crisis, employment and legal concerns.
- Assessing womens needs
- Promote, develop, or assist other entities in providing services/programs to meet women's needs

NCSW Budget and Appropriations:

In March 1984, the 20th anniversary of the Commission was celebrated at a reception at the Governor's Mansion and a dinner at the Capitol Rotunda. One year later, in May 1985, the Unicameral eliminated the entire budget of the Commission. During that year, the Commission and the Nebraska Women's Foundation were able to raise enough money to keep the Commission doors open, but the staff was reduced to one and half, and activities and functions of the Commission were discontinued or transferred to other agencies or organizations.

In 1986 the Legislature refunded the Commission, but only to 40% of the previous budget and then only with the assurance of a "private" partner, the Nebraska Women's Foundation, would continue to support the Commission's activities. In 1989, the commission was included in the Governor's budget for the first time and the legislature passed our funding without having to go for an override. Appropriations and budget concerns continued to be issues that NCSW weathered every biennium over the next twenty years. By 2008 the NCSW, the legislature acted to de-fund the agency in the state, and the NCSW closed its doors.
