# NEBRASKA. CONSTITUTIONAL CONVENTIONS

### HISTORICAL NOTE

The first state constitution was adopted on March 1, 1866. The citizens of Nebraska territory approved the constitution only with great reluctance for in addition to various political considerations, there was a fear that statehood would cost more than the meagre population could support. The first constitution was written with economy in mind and with little consideration given to other important aspects of state government. Indictative of the haste in which the document was drawn is the fact that the Legislature composed the draft rather than a constitutional convention. In addition the constitution was signed by the governor only five days after it was introduced. In the process, no amendments had been permitted, the lower house held no committee hearings and neither houses had printed copies to study.

A constitution written under such conditions soon received criticism from many quarters. As a result a constitutional convention met in 1871 but the voters rejected the submitted document; however, in 1875 a new constitution was drawn up by another convention and it received approval from the electorate.

By the turn of the century, a general revision was needed, according to many, and in 1903 the legislature placed a vote on a constitutional convention on the ballot. Although this effort was defeated, a similar measure was adopted by the people in 1917 and a convention met in December 1919. This body did not draft a new constitution but it did adopt 41 amendments which were approved by the voters and incorporated into the existing constitution.

### SCOPE AND CONTENT NOTE

This collection consists of the Records of the various constitution conventions in Nebraska's history. The files are organized into the following series: (1) Correspondence, 1904-1919; (2) Initiative Petitions, 1916; (3) Printed Material, 1919; (4) Newspaper Clippings 1875-1919; and (5) Miscellany, 1875-1919, undated. (6) 1875, Convention (7) 1920 Convention

This collection primarily consists of records of correspondence and petitions from the various groups working for changes in the State Constitution during 1914-1919. The bulk of the material consists of correspondence

of such organizations as the Voters' Legislative League of Nebraska, Non-partisan League of Nebraska, the Nebraska Constitution Convention Committee and the Nebraska Popular Government League. Background material relating to the convention of 1919 can be obtained from the various histories in the collection and aspects of both the 1919-1920 and 1875 convention are covered by newspaper clippings.
