#### HISTORICAL NOTE

Although Dixon County was organized and its boundaries defined on January 26, 1856, it was attached to its neighbor on the east, Dakota County, for legislative, judicial and revenue purposes. On November 1, 1858 it became a separate county by act of the State Legislature. Its boundaries were later redefined on January 13, 1860.

The first county election was held on December 12, 1858, with the purpose of electing county officials. In addition, the county seat was selected at the same election. Four communities, Ponca, Ionia, Concord, and North Bend, vied for the site. Ponca, however, received more votes than the other towns combined and, therefore, secured the position of county seat. The site of the county seat has been a frequent point of contention with elections for county seat removal held several times.

Dixon County was named by the State Legislature in honor of an early pioneer.

Subgroup One, Assessor, contains real and personal property assessments for Dixon County, 1899-1986 (incomplete)

Subgroup Two, Treasurer, is arranged into seven series: 1) Tax Lists, 1867-1976; 2) Motor Vehicle Tax Lists; 3) Delinquent Tax Lists, 1870-1930; 3) Tax Sale and Redemption Records, 1875-1882; 5) Special Assessments, 1922-1962; 6) School Land Records, 1873-1907; and 7) Miscellaneous Volumes, 1934-1940.

The Tax ListS for 1901 are missing as well as Personal Tax Lists, 1904-1909.

Subgroup Three is arranged in three series: 1) County Board Proceedings, 1860-1968; 2) Cooperative Extension, 1934-1942; and 3) Correspondence & Supplemental Documents, 1869-1900. Series One consists of the proceedings of minutes of the Dixon County Board of Commissioners on microfilm, 1860-1968. Also included in this series is a volume of minutes for Ponca Township, 1908-1914. Series Two includes annual reports of cooperative extension work in the county, 1934-1942. The final Series includes road petitions and records, 1870-1900.

The Election Records of Subgroup Four consist of Abstracts of Votes Cast, 1907-1970 for primary and general elections. Election results are provided for each precinct. Also listed in this Subgroup are three early voter registration dockets which were eventually used for other things and are filed in another subgroup. These dockets include scattered voter registration entries 1858-1869 and can be found filed in Subgroup Seven, County Court.

Records of the County Clerk's Office, Subgroup Five, are divided into six subgroups: 1) Marriages, 1861-1926; 2) Bond Records (no record); 3) Medical Registers, 1881-1994; 4) Brand and Estray Records, 1928-1935; 5) Militia Lists (no record); and 6) Miscellaneous volumes, 1911-1981.

Series one contains one reel of microfilm for Dixon County Marriages, 1872-1886, which was microfilmed by the county in 1989, and five reels of microfilm from the Genealogical Society of Utah's microfilm project in 1994. This film includes licenses & certificates for marriages in the county, 1861-1926 which have

recently been accessioned (1994). Patrons are encouraged to read the inventory of this series carefully for detailed information.

Series Three contains all the registers for physicians, dentists, embalmers, etc. for the county, 1881-1994.

Series Four, Brand & Estray Records contains bounty affidavits, 1928-1935.

Miscellaneous volumes of this subgroup include several folders of burial permits arranged alphabetically, 1977-1981, and a volume registering Farm, Home, and Ranch Names, 1911-1942.

The maps in Subgroup Five, Register of Deeds, include title maps, 1919 and Cadastral maps, 1965, used for delineating property lines and valuations in the county. These maps have not as yet been inventoried. Also included in this subgroup are a few homestead and land grant certificates, 1862-1878.

Subgroup Six, County Court, includes two volumes used by the probate judge of the county. One registers inventories of estates, and one accounts and civil miscellaneous, 1870-1873.

The Archives has not accessioned the most important records of the District Court, Subgroup Seven, including Naturalizations, General Indices, Appearance Dockets, Daily Journals, Complete Record, or civil and criminal case files. Those interested in researching these records should contact the District Court at Ponca, Nebraska.

Subgroup Eight, Superintendent of Schools, contains a register of teachers' examination grades and registrations, 1930-1949, and scattered annual reports from individual school districts to the Supt., 1915-1933.

The final Subgroup contains a compiled set of school district Attendance and Classification records for the districts in the county, 1958-1963, probably compiled prior to consolidation. Also contained in the subgroup are records for School Districts #2, #41, and an attendance register for School Dist. #75, 1953-1955.

The Proceedings and Election records of Dixon County were loaned for microfilming by the County Clerk in July 1973. Tax Lists and assessment schedules as well as the rest of this collection were picked up by the Archives in July of 1993.
