#### HISTORICAL NOTE

Ralph Gilmour Brooks, the 29th governor of Nebraska, was born on July 6, 1898 in Eustis, Nebraska. His parents were the late Mr. and Mrs. A. Hansford Brooks. His father was a farmer and operated a store. During Brook's childhood, his family lived at Kearney, Elm Creek and Sargent. After graduating from Sargent High School in 1916, he taught for a few years in Cherry and Custer County schools. He then enrolled at Nebraska Wesleyan University in 1920 where he captured numerous debate honors and won the National Oratorical Peace Contest in 1923. While an undergraduate he became a member of the College Council and assistant editor of the college paper. Also he worked for the State Highway Department as associate editor of the department's magazine. Upon college graduation in 1925, Brooks attended the University of Nebraska College of Law and, although never practicing in the profession, was admitted to the Nebraska Bar Association in 1930.

At this time he returned to the teaching profession. While at his first teaching job in Hartington, Nebraska after securing his law degree, he obtained a Masters of Art in school administration from the University in 1932. Serving at a number of high schools in Nebraska and Iowa, he moved to McCook in 1946 and assumed the duties of superintendent of schools and president of McCook Junior College.

Brooks' interest in political office began in 1942 when he sought election to Congress in 1942. After winning the Democratic nomination for Congress in the first District, he lost to Republican Carl Curtis in the general election. Sixteen years later, however, the McCook educator was elected the State Governor on November 8, 1958 in a narrow upset victory over the incumbent, Republican Governor Victor Anderson. Brooks' election marked the first Nebraska Chief Executive belonging to the Democratic party in 18 years.

Agressive industrial expansion in Nebraska received top priority during the Brooks administration. Due in large part to his efforts, a special legislative session in the summer of 1960 passed two bills he had proposed to promote industry in Nebraska. In addition the governor fought for an accelerated Interstate Highway construction program as well as promotion of traffic safety.

The governor was active in numerous community, fraternal and professional organizations. He served as district governor of Lions International, president of the Nebraska School Masters Club and president of the Nebraska Association of Colleges and Universities. In addition he was a Rotarian, a Mason, a Shriner and a member of the Elks, Eagles, University Club, Atheltic Club, Chamber of Commerce and Phi Delta Kappa.

The 62 year old governor died on September 9, 1960 after having been hospitalized in late August for upper respiratory virus infection. Within a short time complications developed and he was placed on the critical list with "congestive heart failure." He was survived by his wife, the former Darlene Day of Barneston, Nebraska. Mr. Brooks was divorced from his first wife, Opal E. Gembler in 1930 after a 6 year marriage. They had one daughter Mrs. Robert Reghler of Hollywood, California.

## SCOPE AND CONTENT NOTE

This subgroup consists of the official files of Ralph G. Brooks in 43 paige boxes arranged into three series: (1) Correspondence and Special Subject Files, 1959-1960; (2) Correspondence and Special Subject Files, 1957-1960 (restructed); and (3) Audit Reports, 1958-1960.

The material in series one has been maintained as transferred to the Nebraska State Historical Society from the Governor's office while the later two series have been restructed from a mass of unorganized data. The reason for the descrepency in organization is probably related to the fact that Governor Brooks died in the later part of his first term as Governor and time did not permit the Executive staff to incorporate the unorganized files into the existing filing structure. Therefore the later two series have been organized so as to include the unorganized material in meaningful manner without effecting the contents of the original files.

Since the originally organized Correspondence and Special Files for 1959-1960 werestructured so that the Governor's correspondence and Special records were combined in the same series, no effort was made to seperate the two types of material in the remainding similar series.
