Charles Thone was born in Hartington, Nebraska, January 4, 1924. Graduate, Hartington High School, 1940; University of Nebraska Law School, 1950. Infantry NCQ. Officer, World War II (3½ years). Married Ruth Raymond, August 16, 1953; three children: Ann, Mary, and Amy. Is an attorney. Deputy Secretary of State, 1950-1951; Assistant Attorney General, 1951-1952; Assistant United States District Attorney, Lincoln, 1952-1954; administrative assistant to United States Senator Roman L. Hruska, 1954-1959. Nebraska representative, United States Senator Dwight P. Griswold, 1951-1952; delegate-at-large, GOP presidential elector for Nebraska, 1952, 1956, 1960, and 1968; chairman, Nebraska delegation to 1972-1980 Republican National Convention. Selected as Lincoln's Outstanding Young Man, 1953. Past adjutant and commander, American Legion Post No. 3; state president, Jaycees, 1953-1954; charter member and chairman; Lincoln Human Rights Commission, 1968-1969; elected to Supreme Court Judicial Nomination Commission, 1969 for a six-year term. Elected to the United States House of Representatives, November 3, 1970. Re-elected 1972, 1974, 1976. Elected as Governor 1978.
