Background and History:

The Nebraska Commission on Indian Affairs (NCIA) was created by LB 904 of the 82nd session of the Nebraska Legislature (May 22, 1971) with the purpose of monitoring legislation and coordinating activities among tribes, organizations, and state or federal agencies. Its members serve to promote Indian rights and address problems confronted by Nebraska Indians. The Commission currently consists of fourteen members appointed by the Governor of Nebraska and one "ex-officio" member representing the Pawnee tribe. The commission's mission is "to do all things which it may determine to enhance the cause of Indian rights and to develop solutions to problems common to all Nebraska Indians." The commission serves the state liaison between the four headquarter tribes of the Omaha, Ponca, Santee Sioux and Winnebago Tribes of Nebraska. The commission also helps to ensure the sovereignty of both tribal and state governments are recognized and acted upon in a true government-to-government relationship. The commission assists off-reservation Indian communities by assuring the right to equitable opportunities in the areas of housing, employment, education, health care, economic development and human/civil rights within Nebraska.
