## HISTORICAL NOTE

The first permanent settlement in what would become Kimball County, Nebraska, occurred in 1868 with the completion of the Union Pacific Railroad through the area. On November 6, 1888, Kimball County was separated from Cheyenne County and the village of Kimball was designated the county seat. First known as Antelopeville, the town was originally a water station on the Union Pacific Railroad. Both the town and the county were named for Thomas L. Kimball, a vice president and general manager of the railroad.

## SCOPE AND CONTENT NOTE

This record group consists of the records of Kimball County arranged in eight subgroups: 1) Treasurer, 1876-1979; 2) Assessor, 1908-1975; 3) County Clerk, 1874-1941; 4) County Court, 1889-1947; 5) County Board of Commissioners, 1886-1966; 6) Election Records, 1897-1970; 7) Register of Deeds, 1886-1916; 8) District Court, 1906-1955; 9) School District Records, School District #7, 1890-1911.

Subgroup One, Treasurer (on microfilm), is divided into five series: 1) Tax Lists, 1886-1966; 2) Delinquent Tax Lists, 1887-1934; 3) Motor Vehicle Tax Lists, 1935-1953; 4) School Land Records, 1888-1979; and 5) Miscellaneous volumes, 1876-1936. Series One contains personal and real estate tax lists combined in one volume per year, 1886-1919; in two volumes per year, 1920-1929; personal assessments, 1930-1966 (1 vol. per yr); real estate valuations, 1930-1952 (2 vols. per yr); 1953 lands and an Oil Co. Register, 1949; real estate lots, 1954-1966 (1 vol. per yr); and real estate-lands, 1955-1966 (1 vol. per yr). Series Two of this

subgroup consists of Delinquent Tax Lists for Kimball County, 1887-1920 and a tax sale book, 1887-1934. Series Three includes motor vehicle tax lists, 1935-1953. Series Four consists of School Land Lease records, 1888-1979. The final series of this subgroup consists of a plat book/irrigation record, 1876-1911, and bridge, culvert & road expense ledgers, 1925-1936.

Subgroup Two, Assessor (on 46 reels of microfilm), consists of personal property and real estate assessments, 1908-1975. Five-year interval samples begin with the year 1925. Personal only is included, 1945-1975. Also included is an irrigation assessment record, 1936-1947, and Oil Schedules, 1952-1964. Included in Box one following the formal assessment volumes are miscellaneous correspondence and documents of the assessor including railroad, telephone co., utilities, road districts, school district, and county valuation and levies, 1911-1936. Included are Board of Equalization and Assessment complaints and decisions, and certificates of school taxes levied for each district.

Subgroup Three, County Clerk, includes a Mark and Brand Record, 1874-1914, and medical registers, 1887-1931. There is one volume entitled Index to Contracts and Leases, 1929-1941, which covers sales contracts and leases registered with the county clerk on farm machinery, cars, equipment, etc.. Some miscellaneous correspondence of the county clerk can be found in the correspondence of the Board of Commissioners.

Subgroup Four includes records for the County Sheriff (Jail Registers, 1910-1947 and misc. correspondence, 1931-1947) and a Justice Docket for Dix Precinct, 1889-1915.

Subgroup Five consists of the proceedings of the County Board of Commissioners, 1889-1964, on three rolls of microfilm, and one box of correspondence and supplementary documents to the proceeding, 1911-1966 including documents on Court House bonding, 1924-1933; correspondence for Emergency Relief, 1934-1936; annual reports of Cooperative Extension Work in Agriculture and Home Economics, 1936-1940; Contracts (sales, partnerships, 1963-1966); and a county audit, 1966. The oversize of this subgroup includes two maps by the Department of Public Works showing the state highway system through Kimball County, 1929 & 1935.

Subgroup Six, Election Records, includes abstracts of votes cast in primary elections, 1911-1970; general elections, 1910-1968; and election board records, 1897-1924.

Subgroup Seven, Register of Deeds contains only two Mortgage Indebtedness volumes for the county, 1891-1916, a folder with a plat of Antelope precinct, n.d., and a letter describing the area surrounding certain property in Kimball county, 1910.

District Court records of Subgroup Eight include Homestead Final proof filings, 1913-1921, and related correspondence; miscellaneous case file papers, 1915-1928; and naturalizations for Kimball County including a card index, 1899-1954. The naturalizations (excluding the card index) were microfilmed by the Historical Society in 1988.

The initial deposit of Kimball County records was made in February of 1966. Tax Lists and Assessment records through 1960 were transferred to the Archives in July of 1974. Naturalizations, District Court miscellany, Tax Lists 1954-1966, and Assessments 1945-1975 were transferred to the Archives on November 5, 1987.

The proceedings of the County Board and Election Records were borrowed from the Kimball County Clerk in 1974 and microfilmed by the Society. Microfilming of the Tax Lists and Assessment volumes was completed in February, 1988.
