HISTORICAL NOTE

The boundaries of Cass County were defined by an act of the legislature on March 7, 1855 and redefined on January 26, 1856. Plattsmouth, the county seat, is located on the west bank of the Missouri River, a few miles below the mouth of the Platte.

Plattsmouth's first settler was Samuel Martin who, under a special permit from the Secretary of War, crossed the Missouri River early in the spring of 1853 for the purpose of establishing a trading post below the mouth of the Platte. He erected a two-story building within the present town site.

The Plattsmouth Town Company was organized on October 26, 1854. The town was laid out and plotted in November, 1854 by O. N. Tyson. The March 14, 1855 act defining the boundaries of Cass County also incorporated the city of Plattsmouth. On December 29, 1856 Wheatley Mickelwait was elected mayor and three aldermen were chosen. The council proceeded to business on January 29, 1857. Its first ordinance, passed on March 2, 1857, levied a tax of one-half of one per cent on all taxable property within the corporate limits of the city. This money was used to improve streets, alleys, and steamboat landings.

SCOPE AND CONTENT NOTE

This collection consists of thirteen volumes on six rolls of microfilm, arranged in two series: (1) Justice Dockets, 1890-1914; and (2) Police Court Dockets, 1893-1938.

These records relate to court proceedings in Plattsmouth, Nebraska.

Series 1 consists of seven volumes (B-H) of Justice Dockets, 1890-1914. Entries show the justice of the peace, plaintiff and defendant, sheriff's fees, defendant's costs, and the case proceedings, from the filing of the petition or the bill of particulars by the plaintiff to the completion of the case. Witnesses and jurors are sometimes listed. Alphabetical indexes of plaintiffs and defendants are provided in each volume. Volumes are arranged chronologically by date of filing.

The Police Court Dockets of Series 2 consist of six volumes (A-F) covering the years 1893-1938. These volumes are arranged chronologically by date complaint was filed. Information includes the defendant's name, date the complaint was filed, charge against the defendant, arresting officer, how the defendant pled, case proceedings, judge's name, amount of fine and fees, and, sometimes, witnesses. An alphabetical index of defendants is provided in each volume.
