HISTORICAL NOTE

Seward, Nebraska, about 20 miles west of Lincoln, was founded in 1865 by Lewis Moffitt. The town was surveyed and platted in 1868 by Thomas Graham. Seward was incorporated in April of 1870. Seward was made county seat by a special election in 1867. The results were disputed, however, by Milford, a rival for this honor. The matter was resolved when Seward won an 1871 election by a landslide vote. Seward is the home of Concordia College, a private school founded in 1894 by the Lutheran Church-Missouri Synod.

SCOPE AND CONTENT NOTE

This collection consists of Seward, Nebraska municipal records arranged in the following series: 1) City Council, 1870-1887; 2) Ordinances, 1872-1887; 3) Seward Cemetery Board, 1874-1990; and 4) City Clerk's records, 1874-1906.

The bulk of the collection is in microfilm format and shelved in the West Reference Room under RG310. This includes the records of Series One through Series Three. The one volume of the city clerk contains a license and permit record which includes later entries for receipts of fees for water and utilities and taxes received. All types of licenses and permits are recorded for the years 1874-1906.

Records of Series One include by-laws, ordinances, and proceedings of the City Council, 1870-1887. These records were loaned for microfilming by Dr. Thomas Langevin of Concordia College, Seward, Nebraska, in April of 1956.

Series Two contains an Ordinance Book for the Town of Seward, 1872-1887. This book was also loaned by Dr. Langevin.

Series Three includes the records of various cemetery associations, some defunct, in Seward, 1874-1966. Also included are the records of the present Seward Cemetery Board, 1948-1990. The other cemetery associations are Greenwood Cemetery Association, 1878-1966; Seward Cemetery Association, 1874-1990; and Anderson Cemetery Association minutes, 1883-1944. Burial records are

included for the Greenwood and Seward cemeteries. A lot ownership list is included in the records of Anderson cemetery. The last volume on the film contains maps of the three cemeteries documented in the collection.

The records of Series Three were loaned to the Historical Society for microfilming by Jane Graff of Seward on June 14, 1990. It appears that the records of Seward and Greenwood cemeteries were turned over to the city of Seward in 1948. The records of Anderson cemetey were given to Seward in 1951. The By-Laws and minutes of the Seward County Cemetery Association were formerly a manuscript collection in the reference room but were moved to this record group in January 1992. This reel was received by the Historical Society in 1968.
