HISTORICAL NOTE

The Organic Act of May 30, 1854, which created the territory of Nebraska, provided for a Supreme Court consisting of a Chief Justice and two associate justices elected at large. Until the Constitution of 1875, justices of the Supreme Court also presided over the state District Courts. Cases before the Supreme Court became so numerous that the Legislature of 1901 authorized the Court to appoint nine commissioners to aid in clearing the docket. In 1905 the number of commissioners was reduced to six. By a constitutional amendment adopted in November 1908, the Supreme Court was increased from three to seven judges. An amendment in 1920 provided for the election of the six associate justices by the electors of six districts, leaving only the Chief Justice to be elected at large. To expedite the work of the Court, another amendment in that year provided that the Supreme Court might sit in two divisions, and empowered the Chief Justice to appoint district judges to sit with the Supreme Court justices in order to have five judges in each division. Cases involving the constitutionality of a statute and all appeals from a conviction of homicide would still be heard by the undivided court. The Legislatures of 1925 and 1927 provided for six Supreme Court Commissioners. In 1929 the number was reduced to three. When the docket was cleared, the Supreme Court Commission was terminated in 1931.

The merit plan for judicial selection was adopted as a constitutional amendment in November 1962. Vacancies on the bench are filled by gubernatorial appointment from a list selected by a nominating commission. After receiving an appointment a judge must run for retention in office at the next general election following the expiration of three years from the date of his appointment and every six years thereafter. All judicial candidates are unopposed and run on their records. A majority of affirmative votes will retain the judge in office while a majority of negative votes will remove the judge from office. If an incumbent judge is rejected by the electorate in his bid for reelection, the vacancy is filled as described above.

The Supreme Court has original jurisdiction in cases relating to revenue, civil cases in which the state is a party, mandamus, quo warranto, habeas corpus, elections contests involving the state officers other than members of the Legislature, and such appellate jurisdiction as may be provided by law. The Supreme Court is the court of appeal from the District Courts. The judges of the Supreme Court constitute the board of directors of the State Law Library.

SCOPE AND CONTENT NOTE

This record group consists of 81 reels of microfilm containing records of the Nebraska Supreme Court arranged in one series: (1) Nebraska Reports, 1871-1974.

This series includes the printed reports of cases heard in the Supreme Court of Nebraska in 190 volumes. Volume I, which was published in 1871, contains the cases heard by the Supreme Court of the Territory of Nebraska on pages 411-473. The remainder of the cases in that volume as well as all of the cases in Volume II are not dated. Beginning with Volume III, cases are arranged by term of the Court from the January Term 1873 through the September Term 1973.

Each volume contains a table of cases and an index. At the beginning of reel one is filmed a cumulative index to Volumes I-XXV which was published in 1889.

The Nebraska Reports were filmed by the State Archives in the fall of 1975.
