BIOGRAPHICAL NOTE

Born June 11, 1930, on a farm near Milford, Nebraska, Marjorie Welsch attended Camden District 1 public school in Seward County and then junior and senior high in Crete, Nebraska. She went on to attend Doane College (Crete, Neb.) from 1947-1949. Welsch received a B.S. degree in Religious Education from Schauffler College (Cleveland, Ohio) in 1951. She went on to take some graduate courses at George Washington University (Washington, DC) in 1952.

Marjorie Welsch married George R. Manglitz on October 20, 1953. They would have five children and nine grandchildren. From 1951-1953 Marjorie was a parish worker for the Board of National Missions E&R Church in Takoma Park, Maryland and Cincinnati, Ohio. Manglitz was involved in numerous church/non-profit organizations over the years including serving as the Director of Christian Education at churches in Minot, North Dakota; Tifton, Georgia; Beltsville, Maryland; and Lincoln, Nebraska. From 1969-1991 she served as director of the Resource Library of the United Church of Christ Nebraska Conference.

Manglitz was also a charter member of the Lincoln Citizen Advocacy Committee; served as president of the Lincoln Church Women United; served as vice-president and president of Lincoln Chapter #100 of the United Nations Association of the USA (UNA-USA); served as president of the Nebraska Division #414 of the UNA-USA; served as a commissioner and chair of the Lincoln Area Agency on Aging; served as vice-chair of the Lancaster County Democratic Central Committee; was an active member of Bread for the World and Nebraskans for Peace. Manglitz also served on various foundation boards including Concerned Citizens for the Mentally Ill; The Growing Place, Inc.; The World Peace Center, Inc.; and the Prairie Peace Park & Maze, Inc.

Manglitz joined Witness for Peace to stand with Nicaraguan peoples in 1984. She traveled with Bread for the World to Mexico in 1989. Manglitz also joined Work Teams to Northern Chile four separate times from 1992-1999 to help build a school for the Amyra Indian youth.

Due to her continuing service to the community, Manglitz has received numerous honors and awards including Distinguished Service Awards and the Arnold Goodman Award from the Lincoln and Nebraska Chapters of the UNA-USA; the Honored Woman Award from the 17th General Synod UCC; the Quality of Life Award from the League of Women Voters; the Valiant Woman Award from Church Women United; the Paul Kersenbrock Humanitarian award from the Doane College Alumni Council; the Tribute to Women Award from the Lincoln YWCA; the Outstanding Citizen Award from the Lincoln Northeast Rotary Club; and the C.A. Sorensen Award from Nebraska for Alternatives to the Death Penalty (NADP).

SCOPE AND CONTENT NOTE

The collection consists of various files compiled by Marjorie Manglitz documenting the various committees and organizations she has been involved in over the years. The files reflect her service with Church Women United, Bread for the World, the Lincoln Interfaith Council, the Prairie Peace Park, and various other groups, committees and organizations. The collection is not fully processed but an inventory is available.
