HISTORICAL NOTE

The United Spanish War Veterans were organized in 1904 as a national association for the veterans of the Spanish-American War of 1898 and the Philippine Insurrection. Organized much along the line of the earlier Grand Army of the Republic (G.A.R.), the organization had as subordinate divisions, departments, and sub-departments, and individual camps. In addition, annual state and national encampments were held. The United Spanish War Veterans also had an auxiliary which was an outgrowth of womens organizations in support of Spanish-American War veterans dating from 1898.

The Nebraska Department of the United Spanish War Veterans was organized circa 1907. In 1921 the legislature began appropriations for the relief of the veterans and their widows; these funds were expended under the supervision of the Board of Educational Lands and Funds. The United Spanish War Veterans as a national organization was active until 1992 when the last member, Nathan E. Cook, died at the age of 106 at the VA Medical Center in Phoenix, Arizona.

This collection related to the operations and affairs of the Nebraska Department of the United Spanish War Veterans, 1907-1962. The bulk of the records were transferred to the State Archives in 1968 & 1978, and the organization ceased to exist in Nebraska by 1976. The bulk of the material consists of the departmental correspondence administrative, fiscal records, and records of the women's auxiliary. Of interest are files related to the alleged misconduct of Samuel Shove in 1929 in regards to pension matters and there are various diaries and letters relating to the service of the 1st Nebraska Regiment in the Philippines. In addition, the records includes files on the veterans relief fund, ritual books, and encampment records.
