Now you understand of course, that the plea of "Not Guilty by reason of insanity" has been entered for this boy. Now in case, during the course of his trial it should develop that he was suffering at the time of the act from a mental derangement, or a delusion, or an unbalanced mind, or a sub-normal mentality, or feebleness of mind, or from a combination of any two or more such conditions, but not in sufficient degree to justify a conclusion that he was irresponsible, would you still be willing to take them into consideration in deciding whether this boy committed the act with a deliberate and premeditated design to kill or rob, if you were so instructed by the Court?

greater wrong to carry out the death sentence.

Even granting that the defendant is such a serious menace to himself and his fellow men, whether he be in a hospital for the insane or the State Penitentiary, that the world would be better off if he were dead, we should still follow the law. The rule that "the end justifies the means" has no place in our American form of Constitutional government. Probably there have been many lynchings in years long past in which such summary procedure only accelerated the inevitable. But they were still outside of the law. There is a right way and a wrong way of doing things, and two wrongs have never made a right.

For that reason, we respectfully submit that the verdict and sentence imposed herein should be reversed, or, in the alternative, reduced to a life sentence.
