## **Administrative History**

The Commission on Latino-Americans was created with the passage of LB1081 of the 2<sup>nd</sup> session of the 82<sup>nd</sup> Legislature in March 1972. It was originally known as the Mexican American Commission. The 2010 Legislature changed the name with passage of LB139. The commission serves as a link between Nebraska state government and the Latino population. The commission works with public, private and state agencies to serve the needs of Nebraska's Latino Americans on issues such as access to education, housing and health care as well as social, political and economic opportunities. The commission has nine members, appointed by the governor to three-year terms. The governor or the governor's designee serves as an ex officio member. The commission appoints an executive director.
