# History Nebraska Access and Use Fee Schedule

### Effective January 29, 2024

History Nebraska's (HN) collections are held in trust for the people of the State of Nebraska. Providing access to these collections is central to the agency's mission. Physical access to the vast majority of HN holdings are available free of charge at the Potter Reference Room in Lincoln, Nebraska. Access requests that require staff research, lab work, or other special curatorial assistance may incur fees.

History Nebraska offers both copy services and digitization for collections materials including photographs, documents, portions of published materials (according to copyright limitations), moving images, sound recordings, and images of artifacts. These services and fees may be limited, at HN staff discretion, to ensure long term preservation of original materials. This schedule outlines the fees charged by History Nebraska for low resolution digital copies and for high-resolution digital surrogates of collection materials. Additional sizes and/or formats may be available upon request.

Permission for the use of digital images is documented in an agreement between History Nebraska and the user. For details on History Nebraska guidelines for use see: Use Policy."

## **Use Fees**

Use fees support the preservation and maintenance of History Nebraska's collections. No use fees are charged for use by individuals for personal enjoyment, private study, scholarship, or research. Other uses of History Nebraska collections are subject to fees. All use fees are charged on a per use basis.

## Use categories are defined as:

**Personal Use:** The image(s) will be used only in a private home or office, not in a business setting. The images cannot be reproduced or used for sales purposes.

**Non-Commercial Use:** The image(s) will be published, displayed, or broadcast by a 501(c)(3) organization. Nonprofits must provide proof of nonprofit status, such as their nonprofit tax ID number, otherwise known as an Employer Identification Number (EIN).

**Commercial Use:** The image(s) will be published, displayed or broadcast in a commercial environment for profit. This includes commercial websites representing a person or corporation selling goods or services.

**Commercial Use, small scale production:** The image(s) will be published, displayed or broadcast in a commercial environment for profit. Small scale productions may include publications with small print runs (less than 5,000 copies) or independent film productions.
