Administrative History

The Normal School Board was created by an 1867 law. Through a 1921 constitutional amendment, the name was changed to the Board of Education of State Normal Schools, and in 1969 it received its current name of Board of Trustees of Nebraska State Colleges.

The Board has control of the state colleges at Chadron, Peru, and Wayne. The state colleges are responsible to their region for public service and continuing education activities and for select academic transfer and pre-professional degree programs. The Board of Trustees sets policy, appoints an executive director, appoints presidents for each college, fixes their salaries and their duties. It also acquires and disposes of real and personal property of the colleges.

Scope and Content

This collection consists of volumes containing the minutes of the State Normal Board, later the Board of Trustees of Nebraska State Colleges, 1903-2017. They are arranged chronologically.
