1. CALL TO ORDER AND WELCOME AND REMARKS

3. PRESENTATION BY MATT MASON

4. STRATEGIC PLANNING SESSION

4.1 Board Mechanics: communication, dissemination of strategic plan, committee structure, and board responsibilities:
