Governance Committee

Jamie Moore, Chair of the Governance Committee reported the committee met and concluded since the Board is intended to approve policy and staff execute; and the policy was reviewed by the American Alliance of Museums and their peer reviewers during History Nebraska's Reaccreditation process, unless the board begins to sense the policy is not being executed well, there is no need to discuss every deaccession at an item level. However, the entire board should continue to receive the entire Deaccession List for board perusal.

The cover memo that provides a summary of the deaccession proposed by the Collection Committee is appreciated. It is suggested that future cover memos incorporate "In accordance with the agency's AAM approved Collections Management Policy..." The item level list cite reasons for the deaccession to match the terminology in the Collections Management Policy. The committee, also, agreed additional training on Deaccession be included in the board orientation for new members. Sondra will record an updated Deaccession presentation to be a part of this training.

In summary, the Governance Committee encourages continued discussion as it is evidence of an engaged board but sees no need to revisit the Collections Management Policy currently. It supports the diligent work of the staff who do this work.
