- Vacancy for the Second Congressional District seat and one At-Large position. Hope to have in place for the February meeting.
- Today's meeting was a hybrid Virtual/In-Person meeting. No more than half of our annual meetings may be conducted in this manner. In the future we may have to carefully consider which meetings will be hybrid and which will allow Commission members to attend online but not vote.

CHAIRMAN'S UPDATE

- **Time Capsule Discussion**
 - Written description due **March 15, 2026**; contents due **April 30, 2026**.
 - Ideas discussed:
 - State poet contribution (poem by Jewel Rogers).
 - Governor's letter signed by living governors.
 - Nebraska history in 250 words (Candace volunteered to draft).
 - Map with state symbols, motto, indigenous tribes, and notable quotes (e.g., Willa Cather).
 - Due to time, size and funding constraints, the submission will probably be two-sided, 8.5x11 sheet on archival paper.
 - As a part of the national time capsule submission, it was suggested to add printed directions, coordinates to a larger state time capsule that could be created by the Commission with more items reflecting each of Nebraska's counties.
 - Possible inclusion of native seeds (pending durability clarification).
 - Nebraska Prairie Museum's would potentially provide a location.
- **America 250 National Update** will occur Wednesday, January 28th. Key updates will be sent to Commission members.

KEY PARTNER UPDATES:

Great American State Fair, Madeline Hart, Governor's Office: Working directly with the White House. Official dates are set up on June 23rd and open June 25th-July 10th, 2026. Governor's office will appoint a point person. Nebraska will have a pavilion; specialty pavilions include Arts, Innovation, Faith and Family, American Worker and Agriculture. Awaiting logistics and role clarity from White House task force.

Mike Byars, SAR: Planning Liberty Tree dedications, July 4th State Capitol event, July 8th Declaration reading. Thursday, January 29th Congressman Adrian Smith will be here at NSHS to add his signature to the replica Declaration that each state is having signed. They are working to coordinate the additional Nebraska signatures needed. A calendar of planned SAR events was distributed and will be used to create calendar events.

State Capitol Building Projection: Jeff Barnes proposed projection mapping on the building during the week of July 4th. He was asked to create a one-page proposal that could be used to create a feasibility study, funding plan and the governor's approval.

- Website Development: Progress was reported by Chris Vail and should launch soon.
 - Features event submission form, partner registration and logo guidelines.
- Social Media accounts have been created. Additional administrators are needed.
 - Features event submission form, partner registration and logo guidelines.
 - Chris Vail offered to set up a Google Alert to track publicity for 250 events.

Education Update:

- Bre Wilton secured 350 free STEM kits for rural Nebraska schools that relate to American Innovation.
